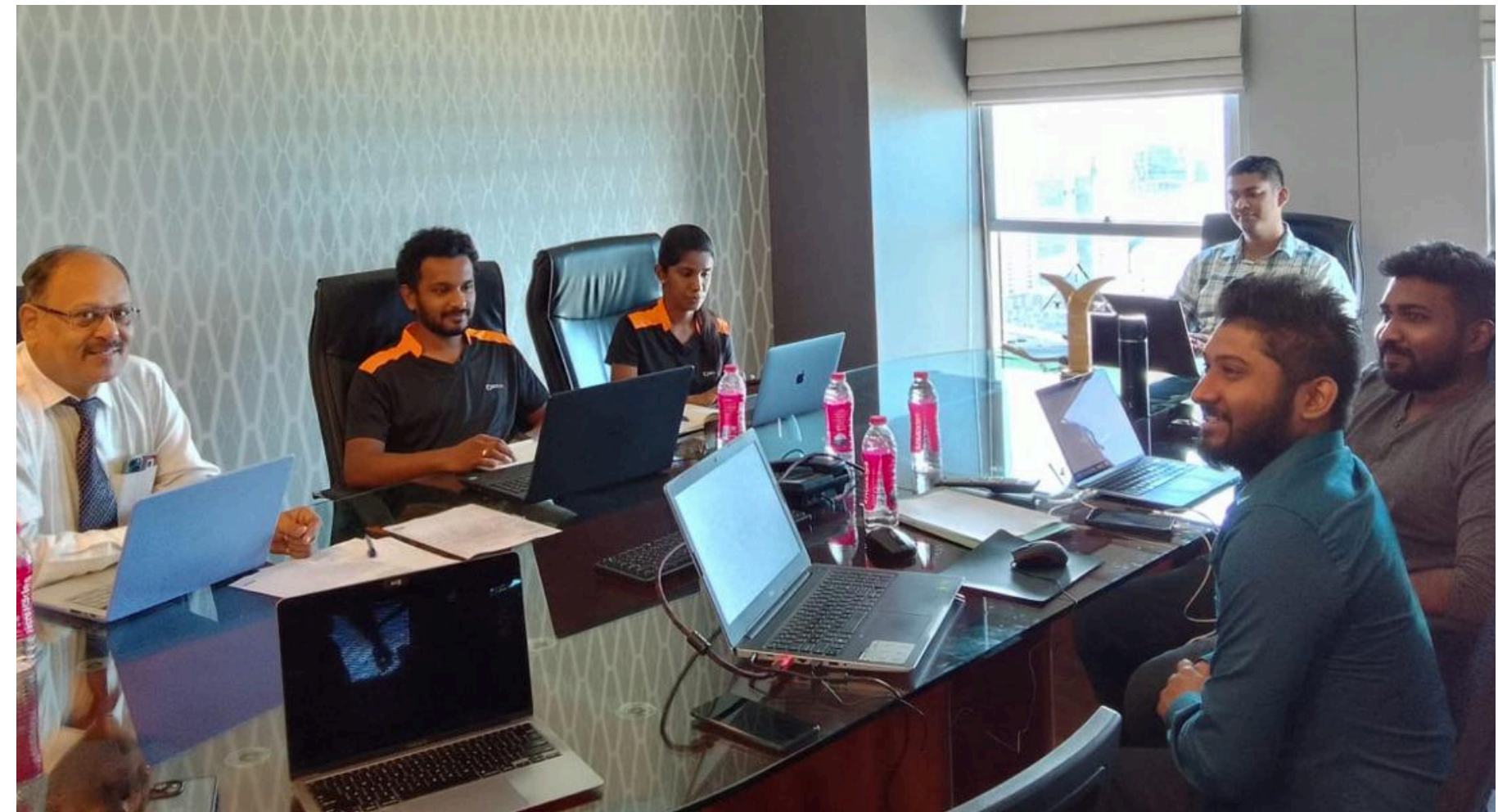
# INFORMATION SECURITY

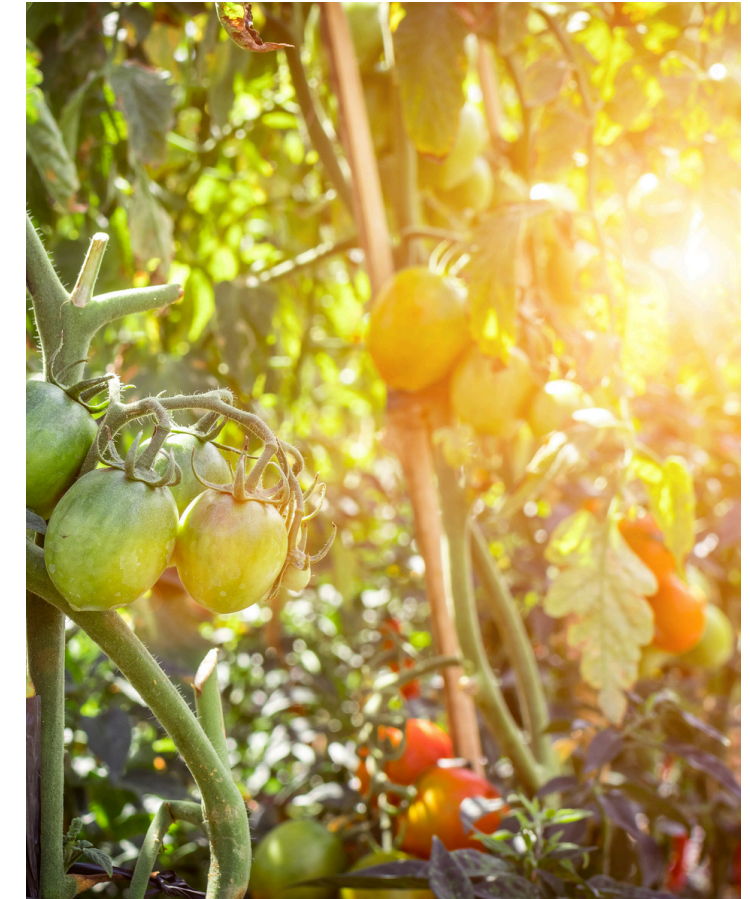

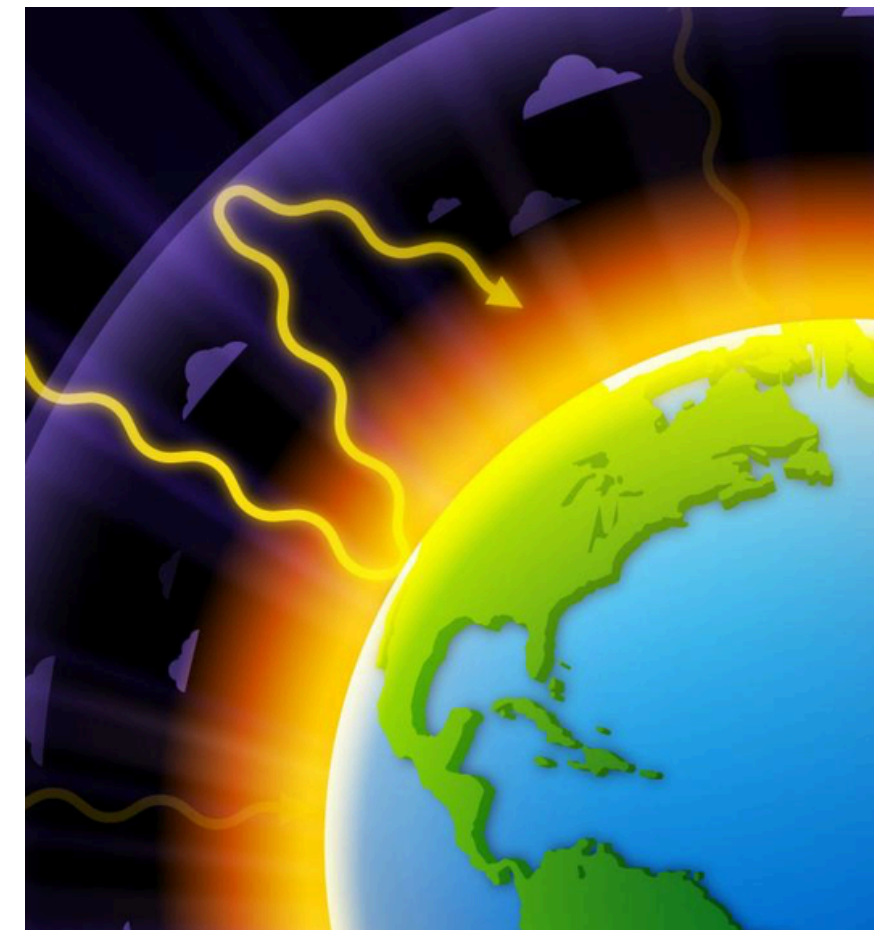
